Applying for the exemption does not in any way alter your responsibility to pay on time any non-resident tuition and fees that may be due before your eligibility is determined. You must complete all sections of this form.

APPLICATION

I, the undersigned, am applying for the non-resident tuition exemption and declare that all of the following apply to me:

- I have attended high school in New Jersey for three or more years; and
- I have graduated from a New Jersey high school or have attained the equivalent thereof, such as a High School Equivalency diploma, issued by the State of New Jersey Department of Education; and
- I am NOT a non-immigrant alien with a currently valid visa.** (Non-immigrants, as defined by federal law, have been admitted to the United States temporarily and may have been granted one of the following visas: A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, P, Q, R, S, T, TN, TD, V, TROV, and NATO or any other non-immigrant visa).
OR I am a dependent of a parent or guardian who holds an H1B Visa. Please attach proof.
