

SUPPORT

If students disclose an incident of sexual misconduct or relationship violence:

- If you have an immediate concern for a student's safety, or if there is an active threat of violence, please call 911.
- Listen without judgment.
- Explain your obligation to report to a Title IX Coordinator.
- Encourage them to contact our **confidential Violence Prevention and Victim Assistance (VPVA) Counselor, Kerry Camerer, at (973) 972-4636.**
- Share information about counseling and medical resources.
- Let students know they also have the option to make a report to the University and/or law enforcement.
- Respect privacy. Although you cannot be confidential, you can respect privacy by only sharing information with a Title IX Coordinator.
- Continue to support and to help students access assistance and accommodations.

Ask for help. You do not have to handle this alone. Sue Hamilton, our RBHS Title IX Coordinator, is here to help.
